NOTIFICATION

No. 1061-SH/SHGSE-13016(99)/1/2018—1st October, 2019.—In exercise of the power conferred by Sub-Section 9.1 and 9.2 of Section 9 (Power to amend and/or relax/repeal) of the Notification No.222-SH/2P-49/07 Date.23.05.2007, the Governor is hereby pleased to issue the following amendments in the said Notification as subsequently amended:-

AMENDMENTS

Sl. No.	Current provision laid down after amendment
1	To reduce the cost of application and time taken in preparation of the applications, Model DPRs of a variety of projects vetted by NABARD would be made available online.
2	0.5% of the budget for the scheme may be used for administrative expenses to be used for monitoring and supervision by the field officials, creating online systems and converging the efforts with different departments. Department shall issue further instruction in this regard.
3	A portal is being developed to make the system transparent and quick. Entire scheme operation from application by the beneficiary to closing of loan account as well as calculation and transfer of incentives to Motivators (Prakalpa Sahayaks) would become online.
4	To increase the quality of applications, a common checklist for evaluation of SVSKP applications and projects developed in consultation with SLBC, shall be used for screening the applications.
5	A simpler and quicker system for small loans (up to Rs 50000) would be developed.
6	In the case where poor people do not get justice at the block level, they can be eligible to write his or her grievance directly to SHG&SE Department for redressal.
7.	Besides this all willing and suitable Utkarsh Bangla trainees would be offered SVSKP loans.

8	To improve the sustainable livelihood in the villages and with a view to generate more employment, the successful trainees under Muktidhara Scheme may get loan from SVSKP scheme so that they can establish their business in villages.
9	Entrepreneurship promotion training to be conducted for all intending entrepreneurs. Suitable modules would be developed for this purpose.

This modification will come into effect from the date of issue of this amendment.
