Rs. 70,250/- per micro project will be given to District Magistrates in SAO Code by the SHG & SE Department.

Role of District Magistrates:-

District Magistrate will sub allot the fund amounting to **Rs.** 68,250/- to the concerned BDOs. Balance **Rs.** 2,000/- per Micro Project is to be utilized for evaluation, supervision and overall monitoring (for hiring of vehicle, etc.) to be done by Block Level Supervisor & District Level Officer of SHG & SE Deptt. during the entire scheme implementation period.

Activities to be undertaken by the BDOs:-

28 days old chicks will be procured by the BDOs from Mother Brooding Units(MBU) run in different districts under Animal Resources Development Department (ARD Department) at the cost as fixed by ARD Department from time to time. BDO will pay Rs. 16,250/- to the MBUs for this.

The SHG will procure the required quantity of poultry feed (Epic chicks feed/ grower feed/ layer feed & good quality feed from any reputed company). The cost of feed (Rs. 51,000/-) upto the point of laying (date of distribution to 24 week age of bird considering disposal of male birds at the age of 3 months) will be given by BDO in two phases directly to the SHGs bank A/C on submission of the copy of Challan/Bill/Voucher/Invoice etc.

Rs. 1,000/- will be given by the BDO directly to the concerned PM/PB/PS/Other AI Workers of ARD Department through DBT Mode after receiving necessary certificates from VO/BLDO of the concerned Block.

Responsibility of SHGs:-

Poultry equipment like feeder, drinker etc. (Rs. 2,000/-) will be procured by the SHGs on their own in consultation with the respective BLDO of the concerned block.

Cost of medicine and feed supplements (Rs. 2,500/-) will be purchased by the SHGs on their own in consultation with VO/BLDO of the concerned Block.

Role of ARD Department:-

The ARD Department will arrange one day orientation training at block level for all members of each selected SHG before distribution of chicks. The estimated cost (Rs. 2,000/-) expended for training will be borne by ARD Deptt. Vaccination will be done by PM/PB/PS/Other AI Workers of ARD Department. The estimated cost (Rs. 1,000/-) expended for this will be borne by ARD Deptt.

Activities to be undertaken by the BDOs:-

20 nos Black Bengal Does will be procured by the BDOs from SHG/Sangha/FPC (Working under ARD Dept. supervision) or from Govt. organization such as CADC etc. (Rs. 3,600/- per Doe X 20 including transportation) Rs. 72,000 will be paid by the BDO for this. Insurance & tagging charges (Rs.4,250/-) will be paid by the BDO. Tagging and Insurance of the purchased goats before distribution must be ensured. Copies of the insurance documents should be shared with beneficiaries (SHGs).

Rs. 1,000/- will be paid by the BDO directly to the concerned PM/PB/other AI Workers of ARD Department through DBT Mode after receiving necessary certificate from VO/BLDO of the concerned Block.

Responsibility of SHGs:-

Cost of medicine and feed supplements (Rs. 2,000/-) to be purchased by the SHGs in consultation with VO/BLDO of the concerned block.

Role of ARD Department:-

The ARD Department will arrange for one day orientation training at block level for all members of each selected SHGs before distribution of goats. The estimated cost (Rs. 2,000/-) expended for training will be borne by ARD Deptt.
