

ORDER

The undersigned is directed by order of the Governor to say that the Governor has been pleased to modify in supersession of all previous orders the Incentive, Bonus and Travelling Allowance payable to the Prokalpa Sahayaks engaged temporarily for implementation of Swami Vivekananda Swarnirbhar Karmasansthan Prakolpo (SVSKP) as follows:-

- (a) Rs.400/- (Rupees four hundred) only as incentive for each project sanctioned by Bank.
 - (b) 0.2% of Sanctioned Project Cost on disbursement of each Project.
 - (c) Moreover, as and when repayment begins, the Prakolpo Sahayaks shall get 1.5% of the total amount recovered plus Rs.1,000/- (Rupees one thousand) only as bonus for timely and full recovery of the loan in each case.
 - (d) Rs.1,000/- (Rupees one thousand) only as fixed travelling allowance in connection with the implementation of SVSKP throughout the State{vide U.O. No.130 Group P(Service) dated 13/01/2011}.
2. The West Bengal Swarojgar Corporation Limited (WBSCL) will sanction and make payment of Travelling allowances and incentives to the Prakolpo Sahayaks as per enhanced rates of the Government.
 3. This order issues with the concurrence at the Finance (Group P1) Department vide their U.O. No. 0082 Group P1/2023-2024 dated 26.05.2023.
 4. The Accountant General (A&E), West Bengal is being informed accordingly.
 5. **This order will take effect from 26th May, 2023.**


