NOTIFICATION

in exercise of the power conferred by Sub-Section 9.1 of Section 9 (power to amend and/or relax/repeal) of the NOTIFICATION No.101/SH/2P-19/09 dt.15.07.09, the Governor is hereby pleased to issue the following amendments in the said Notification, as subsequently amended:

Amendments

1. In the said Notification clause 8.1 should be omitted.

2. For clause 8.2 substitute the following clause:

8.2 All claims for subsidy will be submitted by the respective Bank branches at the end of each six monthly cycle as specified at clause '6' to the office of the local BDO(s) who will verify and send the consolidated claims for each Bank to the District Magistrate concerned. In Urban areas the claims will be sub-allotted by the Bank Branch to the S.D.O. concerned who will verify the claim and send it to the District Magistrate for release of fund. The District Magistrate(s) will release fund to the Banks for crediting in the respective Self Help Group accounts. The Department of Self Help Group & Self Employment will sanction fund for this purpose and a Bank account will be opened in each district by the District Magistrates for operation of the Scheme."

3. For both the clauses numbered 8.3 substitute the following clause :

" 8.3 The entire exercise of submission of claims, their verification and release of subsidy amounts should be completed within 30 working days from the end of each six monthly accounting cycle as specified at clause '6' hereinabove. For this purpose claims are to be submitted by the Bank branches to the respective BDO/SDO within 10 working days. Block Development Officer/ Sub-Divisional Officer will verify and send the consolidated claims to the District Magistrate by the next 10 working days and the release of Subsidy will be completed within the stipulated period of 30 working days from the end of the six monthly accounting cycle."

4. For clause 8.4 substitute the following clause:

" 8.4 The entire bankwise and cyclewise record of claims received, subsidy released and reasons for rejection of claims, wherever applicable, will be sent by the offices of the District Magistrate to the Department of Self Help Group and Self Employment at Writers' Buildings for building a centralized data-base for the State. In due course, this information system will be web-based from the level of the banks to the central data-base."

5. The Governor is further pleased to issue the following direction:

Directions

in the Corrigendum No. 592-SH/2P-19/09 dt. 5.11.09 issued in connection with Notification No. 101-SH/2P-19/09 dt. 17.07.09, omit "clause iii" thereof.
